RE: Cease and Desist

Please be advised that I am writing on behalf of John J. Kennedy in regard to a matter involving the ongoing and unlawful harassment directed against him by you and your associates.

According to Mr. Kennedy, you have allegedly violated numerous civil and criminal laws of the State of Washington. It is my understanding that you have knowingly and maliciously spread false information about Mr. Kennedy and his now-deceased sister, Cecilia Madeline Kennedy, for the specific purpose of harassment, intimidation, and damage to Mr. Kennedy's reputation. Your allegedly unlawful conduct includes, but is not limited to, continuing harassment, intimidation, defamation, illegal wiretapping, mail fraud, and copyright infringement of Mr. Kennedy's literary works.

It is my understanding that Mr. Kennedy issued written demands to you on three occasions during the period October 18-21, 2005, wherein he requested that you immediately cease your continuing course of harassment, intimidation and defamation directed against him, his associates and his family. It is my further understanding that, at that time, Mr. Kennedy also reported your unlawful activities to Mr. Takayoshi Oshima, President and Chief Executive Officer of Allied Telesis, Inc. and Sergeant Boyd Bryant of the Everett Police Department. In addition, Mr. Kennedy reported your alleged theft of the identity of his deceased sister, Cecilia Kennedy, to the Internal Security/Legal Department of Yahoo, Inc.

It is my understanding that, in or about October, 2005, you invited Mr. Kennedy to Washington under false pretenses and misrepresented your professional statuses as an attorney and a business manager. Furthermore, Mr. Kennedy contends that you assaulted and threatened him when he tried to leave your residence peacefully after discovering your deception. In fact, Mr. Kennedy learned that you were both living under false aliases, had harassed his guests at two of his events promoting peace for his campaign for the New Humanity, and had attempted to engage him in a deceptive and fraudulent business contract. In addition, Mr. Kennedy alleges that you were responsible for illegally wire-tapping



him, his friends, and business associates at both your mutual place of residence in Everett, and at place of employment, Allied Telesis, Inc., in Bothell.

This letter serves as written notice, on behalf of Mr. Kennedy, that you immediately cease any and all further communication, or attempts to communicate, with him, including but not limited to, communication via U.S. Mail, telephone, email, or through third parties. You are further requested to cease and desist from directing any and all communications about Mr. Kennedy or his deceased sister to any media outlet, past or present client or associate of Mr. Kennedy's, or any other person, corporation or governmental agency.

If, for any reason, you fail to comply with this request, Mr. Kennedy will have no option but to pursue all criminal and civil remedies available to him. I am certain you are aware that his options include the pursuit, through the district attorney's office, for the issuance of a criminal warrant(s) against you, and the filing of a civil action against you. If it does become necessary to file a civil suit, Mr. Kennedy will seek court costs and attorney's fees, if applicable, in addition to the underlying damages sought.
