

# **CEASE AND DESIST ORDER**

**Internet Crimes (Local, State and Federal Jurisdictions), Cyber-Stalking, Cyber-Bullying, Hacking Into Computers, Emails and Phones, Wiretapping, Stalking, Harassment, Extreme Defamation of Character, Tortuous Interference In A Business, Copyright & Trademark Violations, Identity Theft, etc.**

**To the following Perpetrators/Defendants:**

**STAY THE HELL AWAY FROM ME, MY FAMILY, FRIENDS & BUSINESS!!!**

As per the advice of my attorney, you are hereby given another legal and written Cease and Desist Order to cease from all abuse and illegal and criminal activity directed towards me, my family, friends, business associates and my business enterprises. This includes, claiming you are various bogus “watch groups” to justify your illegal, criminal and abusive actions, which includes but is not limited to: all forms of harassment, extreme defamation (i.e., slander and libel), stalking, cyber-stalking, cyber-bullying, repeated and torturous interference in a business, intimidation, threats, all Internet crimes (i.e., hacking into computers, emails, satellite and Internet wiretapping/Steaganography, spy ware, etc.), copyright and trademark infringements, identity fraud, identity theft, mainly that of our beloved and deceased sister Cecilia Madeline Kennedy (1964-1997), whom you have created numerous fraudulent email accounts (in 2005 and again in 2008) using Cecilia’s full name and date of birth, and perversely sending out emails to me and others, as if she is still alive.

You are hereby legally ordered to remove all content, websites, blogs, Internet postings **within 24 Hours of delivery of this written demand** whereby you have defamed me, my family, friends, business associates, or my business endeavors in any way whatsoever. See attached addendum of the slanderous and libelous remarks you have said about me via U.S. Mail, e-mails, or written or internet sites, blogs, and postings, telephone and word of mouth.

**All of your actions are in direct violation of many State and Federal Statutes.**

You have also contacted many of my esteemed friends, business associates and strangers, and defamed me after hacking into my computer, emails and phones to get my itinerary, my schedule, my business secrets and contacts, and their names, emails, home addresses and personal phone numbers.

**None of this information was ever public or posted on any of my websites as you claimed when you perjured yourself to the Orlando Police Department at the time of your interrogation last year.**

We have turned over evidence to the authorities in Orlando, Florida, Everett, Washington, Bothell, Washington, and the Snohomish County Sheriff's Department and Snohomish Country District Court to prove our case.

You are also given a **24 hour written notice** to remove all copyrighted and/or trademarked properties of my literary work, intellectual properties, photographs, artwork and any content that was written and/or owned by me that you have stolen and used illegally.

Furthermore, you are hereby legally notified to cease and desist any and all wire-tapping or computer hacking via satellite, any and all further communication, or attempts to communicate with me, or any of my family, friends and business associates in any manner whatsoever. This includes, but is not limited to communications via U.S. Mail or other mail-delivery services, telephone, email, or through third parties.

The Right to Free Speech, which I whole-heartedly support, has its limits and legally stops when slander or libel is involved, and/or when any activity is committed through illegal or criminal actions, including, wiretapping, computer hacking and other Internet crimes and manipulations which you, are proficient at,

Pleased be further warned that the Statutes of Limitations remain active and open on every single illegal and criminal infraction, and every single count, as your abuse has been ongoing since 2005 and continues to this day.

On October 12, 2005 \_\_\_\_\_ received the first Cease and Desist that demanded, among other things, that you keep your filthy hands off me and my quests, (especially the children) while at my speaking events.

Again on October 18, 2005, October 20, 2005 and October 27, 2005 \_\_\_\_\_ and her lesbian lover, \_\_\_\_\_, received Cease and Desist Notices.

Again on August 16, 2006 \_\_\_\_\_, et al, officially received another legal Cease & Desist Order from my attorneys at Deming, Parker, Hoffman, Green and Campbell in Norcross, Georgia. It not only named you, but any of your friends and associates. You were again reported to law enforcement in multiple jurisdictions at that time. See attached Exhibit.

Again on September 2008 another Cease and Desist Order was given to (names withheld) as he was the one now doing your bidding. Additional Police reports were also filed at that time, including the IP address, which linked a series of websites that you opened and are operating including: (no longer exists)

The most recent abuse and unlawful Internet activity was reported on August 3, 2009. In September 2008, after filing a police report with the Orlando Police Department, whereby you, were interrogated via telephone at your residence in Hollywood, Florida you were specifically warned to cease and desist from any further abuse, harassment or illegal activity directed towards me or my company. Furthermore, the police specifically warned you that when they discover HOW you have hacked into my computers, emails and phones, that you will be held criminally responsible on every single count. The same goes with the Everett Police and Snohomish County Sheriff's Department and Federal authorities governing Internet Crimes.

All of this has been reported and cross-referenced in official police complaints and lawsuits - and supported by over 100 pages of evidence - to the authorities in Florida, Washington State, as well as the District Court of Snohomish County, etc.

You are hereby given notice that we will continue to pursue all criminal and civil remedies available to us **no matter how long it takes to bring all of you to justice**. Any and all attorney and court fees, further investigation fees, and all monetary damages will be sought against each and everyone of you.

As before, this Cease and Desist Order applies to the above-named individuals and companies, and to any and all of their associates, now or in the future.
